# VENDOR AGREEMENT

## **Health Regulations**

*Health Permit:* All food vendors are required to file a temporary restaurant permit request with the Flagler County Department of Health PRIOR to the event. No vendor will be allowed to begin operations without a permit and without on-site clearance by a Health Inspector. Any vendor not in compliance with the rules and regulation of the Health Department at any time prior to or during the Fly-In event will be subject to removal from the event. Operations that are listed by the Flagler County Health District as having a critical violation during the inspection of their operation will not be invited to return to future fly-in events.

## **Fire Regulations**

All vendors are required to comply with the fire safety regulations set forth by the Flagler County Fire Department. Questions should be addressed to the Fire Marshall's office.

## **Licenses**

All Fly-In event commercial vendors must operate under a Flagler County business license. If you already have a 2010 business license, please submit a photocopy of it with your vendor application.

## **Structures**

If your structure is not self-contained, you must construct a well-decorated booth or tent. Any structure containing fabric will require a Flame Retardant Tag on the tent/fabric and a Flame Retardant Certificate, which must be submitted to our office with this application. The "Wings Over Flagler" Director will be carefully reviewing all photographs, diagrams, etc. prior to selecting vendors for 2010. We will be looking particularly for operations that are visually appealing.

## **Insurance**

Submit with this application a Certificate of Insurance to include following limits: Combined Bodily Injury and Property Damage Liability limit, including Product Liability of \$1,000,000. Certificate dates should read "in effect from March 26, 2010 through March 28, 2010" and should list "Flagler County Board of County Commissioners" as an additional insured.
